A regular meeting of the Board of Commissioners of the Township of Haddon was convened in the Municipal Building, 135 Haddon Avenue, Westmont, NJ on Tuesday, April 23, 2024 at 7:00 PM.

#### **ORDINANCES:**

# 2<sup>nd</sup> Reading/Public Hearing

#1452 – Ordinance of the Township of Haddon, County of Camden, and State of New Jersey Amending and Supplementing the Township of Haddon Code at Chapter 142 "Land Use and Development", Article 1, Section 142-38 to Repeal and Replace the Cannabis "Opt Out" Provisions of Section 142-5P with Article V, Section 142-38I to Authorize Class 1,2,3 and 5 Cannabis Licensure as a Conditional Use in Certain Zoning Districts and to Define the Term "Cannabis Microbusiness" in accordance with State Law

Commissioner Mulroy moved, seconded by Commissioner Linhart that the public hearing on the Ordinance would be open at this time, with all members voting in the affirmative.

John Kendall, 120 Washington Avenue – Mr. Kendall inquired as to the process once approved for a cannabis business to start. Mayor Teague responded as follows, first there would have to be someone interested in opening a cannabis business pursuant to one of the licenses the Township is offering, and second, they would have to acquire or rent a property that is within the designated areas, third they would make application to the Planning Board. Mr. Kendall wanted to know if it would be advertised that these licenses are available or is it just public knowledge. Mayor Teague responded, it is just public knowledge and he reiterated the Township is not cannabis hunting. Mr. Kendall mentioned that area across Route 130 (Red Barn and Sgt. Scrap area), if that area was in the zone. Mayor Teague responded in the affirmative. Mr. Kendall further stated that the area across from Red Barn and Sgt. Scrap are in the area as well as all of Black Horse Pike? Mayor Teague responded it is those areas that are C3 and industrial zoned, C3 is heavy commercial, other requirements need to be fulfilled such as parking. Mr. Kendall inquired as to the parking requirement. Mayor Teague responded 5.5 spots, one for retail 1,000 feet and a spot for an employee, if it's retail. It's one per 1,000 if it's the other license.

Debbie Kraponick, 210 Wilson Avenue – Ms. Kraponick inquired in reference to zones and parking, how far away from homes and schools are the limits. Mayor Teague responded it

is the zone requirements for those areas. She further inquired if they are the same for whatever business is zoned for those areas. Mayor Teague responded in the affirmative. Ms. Kraponick asked if there are any other areas that she's not aware of and Mayor Teague responded any area such as trucking. Those areas are highways, 4 lane highways, you tend to get more of the C3 heavy commercial and industrial type of highways. She asked specifically about the area where the Barber Shop is in West Collingswood Heights and Mayor Teague responded he is not sure if that is zoned C3. Mayor Teague replies it does not appear to be zoned C3 from what he recalls about that property. Commissioner Linhart responded, the interested party would bring an application to the Planning Board and the determination would be made at that point. Commissioner Mulroy inquired if there is a source she can use to see what the different zones are in the area. Commissioner Linhart responded, if you google Haddon Township Tax Map you should get a pdf with the zones.

There being no further discussion on the matter, Commissioner Mulroy moved, seconded by Commissioner Linhart that the hearing be closed. Commissioner Mulroy moved, seconded by Commissioner Linhart that the Ordinance be adopted and recorded in the Ordinance Book for the Commissioners to sign.

## 2<sup>nd</sup> Reading/Public Hearing:

#1453 – Ordinance of the Township of Haddon, County of Camden, State of New Jersey Amending and Supplementing the Code of the Township of Haddon at Chapter 212, Taxation, to Establish Article V. "Municipal Cannabis Tax" Section 212-16, to Collect a Statutorily Authorized Two Percent (2%) Municipal Tax on Sales by Class 1 Cultivation, Class 2 Manufacturing and Class 5 Retail Cannabis License Holders and One Percent (1%) Municipal Tax on Class 3 Wholesale Cannabis License Holders

Commissioner Mulroy moved, seconded by Commissioner Linhart that the public hearing on the Ordinance would be open at this time, with all members voting in the affirmative.

John Kendall, 120 Washington Avenue – Mr. Kendall inquired if this is for the 2% tax on the cannabis that would come to the municipality. Mayor Teague responded in the affirmative. Mr. Kendall reported that since West Collingswood Heights is the neighborhood that is affected, if a portion of those monies raised can be used for improvements for West Collingwood Heights neighborhood. Mayor Teague responded they are Township's and it goes throughout the Township, they are not designated for one area nor can they be designated for one particular area. Mayor Teague also explained that those areas, if there is an interested cannabis party, that they will improve some of those areas along Black Horse Pike or Route 130. Mayor Teague further explains we waited to do this to see what arose from other towns and even after this is approved, we will keep an eye on it so that we can address any issues that come up such as an increase in traffic, which would immediately be addressed with the police. If there are funds needed to assist with the cannabis sale, we will spend those funds there. Mr. Kendall stated, he believes he was told last week the area that is for sale is the adult bookstore, What-a-wiener and the warehouse. Mayor Teague explained that the adult bookstore, which is operational and What-a-wiener are owned by the same person and the warehouse is owned by someone else and all of that is for sale. He does not know if the prices they are asking are reasonable or not. Mr. Kendall replied that someone else could buy that area that has nothing to do with cannabis. Mayor Teague responded in the affirmative.

There being no further discussion on the matter, Commissioner Mulroy moved, seconded by Commissioner Linhart that the hearing be closed. Commissioner Mulroy moved, seconded by Commissioner Linhart that the Ordinance be adopted and recorded in the Ordinance Book for the Commissioners to sign.

## **PUBLIC COMMENT**

There being no further business on the agenda, Commissioner Mulroy made a motion to open the meeting for public comment, seconded by Commissioner Linhart, with all members affirmatively concurring:

John Kendall, 120 Washington Avenue – Mr. Kendall asked if there was any word on the old Oaklyn Diner property. Mayor Teague responded in the negative and continued by saying there was an interested party one year ago and when they went through the Planning Board they were not approved and they moved on. Mr. Kendall asked if they were still paying their taxes and if someone still owns it and is it still for sale? Mayor Teague responded in the affirmative. Mr. Kendall stated we could use a diner; there aren't that many diners in South Jersey anymore. Mr. Kendall asked what the vehicles and traffic ordinance pertains to. Mayor Teague responded that when Reunion Hall received its approval to operate at their current location, there was a concern that on Glenwood Avenue there are a number of homes that don't have driveways and due to the close proximity to Reunion Hall, there was a concern that they wouldn't be able to park their vehicles. The Planning Board made a recommendation to designate spots for those that did not have driveways. As Reunion Hall has opened, they have been doing very well, it's a nice place, and it has been very crowded. They are using a lot of those spots in the evening time where the residences don't have driveways would ordinarily park their vehicles. In some cases, they would go out to the store and comeback and there wouldn't be anywhere to park. We took an area that is right across the street from where these homes are, it's almost like a cutout on the street, and we are delineating those areas as parking areas for those homes that do not have driveways. Those homes that do have driveways will be required to park in their driveways. Mr. Kendall stated that he thinks it's great that the Township is going to improve the playground in the Heights and requested details. Mayor Teague responded that

they did the lower softball field last year by improving the drainage and they asked if we could do something with the softball field above, which is in closer proximity to the playground and we did that too. He further reported the Township applied for \$25,000 recreation grant last year just to upgrade and expand the playground equipment are applying for another \$25,000 as well and we still have another larger outstanding grant to address some of the other drainage issues on the rest of the field and we have not heard on that one. Mr. Kendall mentioned 3 little gulleys in the walking track that are filling with water and he asked if they can be filled in with dirt so the water doesn't collect there for mosquitos. Commissioner Linhart responded that he believes that area is deemed wetlands and you are not allowed to fill that in. Mayor Teague responded that we will have Greg Fusco, PE take a look at that area. Mr. Kendall also asked for more trees in the area and gravel stone where people park to cutdown on the mud. It was good that a new roof was put on the gazebo last year and mentions the other two need new roofs, too. Mr. Kendall mentioned, the Crystal Lake Pool concession stand was a disaster last year due to the vendor leaving early and they were hardly ever there. Mayor Teague responded that it actually was the last two years, so we have a new vendor this year. He pointed out that it hasn't been easy getting agencies to bid so we are left to go with those that bid or are interested. This year we have someone that we think is going to work out well. It's called Lefty's Dogs and they are going to do hotdogs, hamburgers, etc. Mr. Kendall ended by informing the governing body they are doing a good job and to keep up the good work.

There being no further public comments, Commissioner Mulroy moved to close the meeting for public comment, seconded by Commissioner Linhart, with all members voting in the affirmative.

## **ADJOURNMENT**

There being no further business to discuss, Commissioner Mulroy moved, seconded by Commissioner Linhart that the meeting be adjourned at 7:33 PM, with all members voting in the affirmative.
